### Oral Health Initiative - AAPA

As of 2014, the AAACP began transitioning newly certified PAs to a ten-year certification maintenance cycle (it was previously a six-year cycle), which is divided into five, two-year periods. During every two-year period, you must earn at least 100 CME credits and submit a certification maintenance fee of \$130 to the NCCPA by December 31 of your certification expiration year.

Individuals who have never been certified and who graduated from an ARC-PA accredited physician assistant program on or after January 1, 2003, will be eligible to take PANCE for up to six years after completing the requirements for graduation from that program. (A) For purposes of Chapter 4730. of the Administrative Code: (1) "On-site supervision" means the supervising physician is required to be physically present in the same location as the physician assistant, but does not require the supervising physician's physical presence in the same room.

After graduation, all 50 states and the District of Columbia require PAs to obtain a professional license. To do this, you must pass the Physician Assistant National Certifying Examination (PANCE), which the National Commission on Certification of Physician Assistants (NCCPA) administers.
