The system's goal is to make sure that Federal trade, craft, and laboring employees within a local wage area who perform the same duties receive the same rate of pay.

General Schedule (GS) base pay varies from the GS-1 level at \$19,543 per annum to \$142,180 per annum at step 10 of the GS-15 grade, not including locality pay adjustments. The Senior Executive Service salary tops out at \$219,200 per annum. The average annual salary for full-time non-postal employees has increased to just over \$83,500 in 2014.

A WG employee moving to another WG position at the same grade in a lower wage area is not eligible for pay retention. The pay retention regulations at 536.303(a) provide that a reduction in an employee's payable rate of basic pay resulting from a geographic conversion is not a basis for entitlement to pay retention.
