Look out for broken glass and exposed nails. Always assume that downed power lines are energized and dangerous. Stay at least 10 feet away and alert the police and utility company. If your vehicle is in deep water, be careful when restarting, as it may cause irreparable damage to the engine.

If poor road conditions damage your vehicle, your insurance company is unlikely to cover it because it's hard to prove that you weren't at fault or that the damage, if not aesthetic, is anything other than general wear and tear, which insurance does not cover.

How to File a Claim When Bad Roads Damage Your Car ...

Contact your insurance company as soon as possible to report the accident, even if you could not find the owner. This way they have your side of the story when the person you hit calls in their claim. In addition, it gets your insurer started on your claim to repair the damage to your vehicle.

Parking Lot Accidents: What to do if you Hit a Parked Car ...

Fill out a Damage Claim form Submit the Damage Claim form along with 2 repair estimates or a paid invoice to the SCDOT Maintenance Office in the county where the incident occurred. (If the damage is to a vehicle, the claimant must be the registered owner, and a copy of the vehicle registration must be included.)

How do I file a claim against SCDOT?

Collision coverage on your car insurance policy will cover the damage to the car, and homeowner's insurance will cover damage to the garage door. Remember, liability insurance on any type of insurance policy does not cover damage you cause to your own property, and collision insurance only covers your car. Scenario 3: When You Get Hurt
