In the case of procurement contracts to be financed by ADB under its nonsovereign operations from the proceeds of (i) an ADB loan, (ii) a loan guaranteed by ADB, or (iii) a grant to a private sector recipient, procurement shall be carried out following established private sector or commercial practices acceptable to ADB.
