### Answering Request For Production Of

Vague request for production responses can be treated as a failure to respond. See Rule 37(a)(3), SCRPC ("an evasive or incomplete answer [to discovery] is to be treated as a failure to answer"). Furthermore, a response that isn't clear in what is being produced can lead to problems at trial.

### Best practices in responding to requests for production ...

This request is called a Request for Production. In addition to requesting documents, the other side might request to inspect or photograph other pieces of evidence. To respond, you first need to read each request and see if the document or object requested is in your possession, custody, or control.

### How to Respond to a Request for Production (with Pictures)

Unless the court allows a shorter or longer period of time, a response to a request for production is due thirty days after service, unless the defendant was served with the request for production at the time of service of process (in which case the defendant has forty-five days to respond).

### Responding to Requests for Production or Inspection

"Requests for production" are written demands, usually requiring the other side to produce copies of documents he possesses or can readily obtain. But the requests could be broader too. They could request to inspect or test some item. Or they could request to enter property to inspect it and take pictures or samples or surveys.

### Responding To The Other Side's Requests For Information ...

Instructions to the Answering Party (a) An answer or other appropriate response must be given to each request for production of documents. Parties are to provide documents in response to these requests for production of documents with the understanding that they stand in a fiduciary relationship with each other.

### Section 1. Instructions to All Parties Section 2 ...

A party that responds to a discovery request by simply producing electronically stored information in a form of its choice, without identifying that form in advance of the production in the response required by Rule 34(b), runs a risk that the requesting party can show that the produced form is not reasonably usable and that it is entitled to production of some or all of the information in an additional form.

### Rule 34. Producing Documents, Electronically Stored ...

The matter is admitted unless, within 30 days after service of the request, or within such shorter or longer time as the court may allow or as the parties may agree to in writing, subject to Rule 29, the party to whom the request is directed serves upon the party requesting the admission a written answer or objection addressed to the matter ...
