To be acceptable under California laws and regulations, heavy metals analyses must ■ Include values for Arsenic, Cadmium, Cobalt, Copper, Lead, Mercury, Molybdenum, Nickel, and Selenium, and ■ Be performed within the last fiveyears, and ■ Be performed using sample preparation method 3050B or 3051 and using analytical methods described in US EPA Publication SW-846.
