To qualify for a summary dissolution of your domestic partnership you must meet ALL of the following requirements. You and your domestic partner: Both want to terminate your domestic partnership; Have not been registered as a domestic partnership for more than 5 years on the date you file your Notice of Termination of Domestic Partnership;

For Domestic Partners - divorce or separation selfhelp

A Petition for Dissolution of Domestic Partnership and Marriage is a formal request by one partner/spouse to a California Superior Court to dissolve both the domestic partnership and the marriage in a single proceeding. A judgment issued by the court in this case will end both the domestic partnership and the marriage.

A Partnership Dissolution Agreement is a document used by two or more Partners who are in a business Partnership together to end the Partnership. This Agreement creates a plan for completing an inventory of the Partnerships holdings, settling the Partnership's obligations and debts, and distributing any remaining Partnership assets to the Partners.

This one-page form must be filled out completely and the signatures of each partner notarized separately. The registration fee of \$50 includes a black and white certificate. A ceremonial certificate is available for an additional \$15. Partners must also indicate if they would like to pick up their certificate in person or have it mailed to them.

Nevada Secretary of State : Domestic Partnerships

The Domestic Partners Registry registers same-sex couples regardless of the age of the partners, and opposite-sex couples in which one partner is at least 62 years old, as domestic partners in California when they file a Declaration of Domestic Partnership.
