### Damage Investigations . . . a utility's perspective

As a guideline, the PUC considers property damage exceeding \$50,000 to be significant. This Rule is applicable to all electric utilities, including rural electric associations (REAs). An incident must be reported telephonically to the PUC within two hours of the utility becoming aware of it. The PUC number for reporting an incident is 303-894-2528.
