Your essay should be typed and double-spaced on standard-sized paper (8.5" x 11"), with 1" margins on all sides. You should use a clear font that is highly readable. APA recommends using 12 pt. Times New Roman font. Include a page header (also known as the " running head ") at the top of every page.

The Method section of an APA-style paper is the most straightforward to write, but requires precision. Your goal is to describe the details of your study in such a way that another researcher could duplicate your methods exactly. The Method section typically includes Participants, Materials and/or Apparatus, and Procedure sections.

Insert a running head and page number. Set page margins to 1 inch (2.54cm). Write “Abstract” (bold and centered) at the top of the page.

APA Abstract (2020) | Formatting, Length, and Keywords

In APA format, there are two key rules for citing a source in the text of the paper. First, in APA format, quotations are cited by author, year and page number. All other citations that are not quotations are cited only by author and year. When there is no page number available, the page number is omitted.
