A direct quotation reproduces words verbatim from another work or from your own previously published work. It is best to paraphrase sources rather than directly quoting them because paraphrasing allows you to fit material to the context of your paper and writing style.. Use direct quotations rather than paraphrasing:

Quotations - APA Style

Pick a standard and simple-to-read text style like Times New Roman. Likewise, the APA requires the utilization of text styles without serifs. (Serifs are the little bars put toward the end of the strokes of a letter. For instance, Times New Roman has serifs; however, Arial does not.)

If there is more than one author, use an ampersand (&) before the name of the last author. If there are more than six authors, list only the first one and use et al. for the rest. Place the date of publication in parentheses immediately after the name of the author. Place a period after the closing parenthesis.

Writing a Bibliography: APA Format - Science Buddies

List the last name, comma and first initial of every author. Put the date the article was published in parentheses. Write the title of the article with only the first word capitalized, followed by a period. Write the publication name in italics, followed by volume number if applicable.

Use double quotation marks around the title of an article or chapter, and italicize the title of a periodical, book, brochure, or report. Examples: From the book *Study Guide* (2000) ... or ("Reading," 1999).

Format your citation in the following manner if you are citing a Norton Critical Edition as a single work in APA format. Make sure that the title of the book is italicized and that only the first letter of the title, subtitle and proper nouns are capitalized. Author's Last Name, First Initial. (Year of Publication).
