At the outset, jurisdiction in international law relates to a state's general legal competence to exercise authority over territory and persons by virtue of its sovereignty. 35 One of the most helpful explanations of jurisdiction comes from Frederick A. When two states have proper jurisdiction, we can conceive of no impediment to the parties agreeing to the exercise of proper jurisdiction in one state in lieu of another state which also has proper jurisdiction. The district court merely pointed out the free agreement of the parties to a valid and reasonable jurisdiction.
