In regards to social workers licensed outside of South Carolina, pursuant to S.C. Code Section 40-63-290(6): Social workers so licensed in another jurisdiction may, after notice to the Board, practice within the scope of their licenses during or immediately following a declared or recognized emergency for a period not to exceed 60 days.
