Reasons for an Autopsy < Pathology

Autopsy from the Greek 'autos' and 'opsomeri' means 'to see for oneself'.¹²Its history stems from mummification and human dissection in 3000 BC, through ancient Greece where Hicrophilus discovered the duodenum by live human dissection to Rokitansky (1804-1878), regarded as the father of the modern autopsy and who performed or supervised over 100 000 examinations.¹
