he Labor-Management Reporting and Disclosure Act (LMRDA) guarantees certain rights to union members and imposes certain responsibilities on union officers to ensure union democracy, financial integrity and transparency. The Office of Labor-Management Standards (OLMS) is the Federal agency with primary authority to enforce many LMRDA provisions.

Union Members: Know Your Rights - DOL

Explain that the rights of union stewards are protected by our contract and by labor law—the National Labor Relations Act (NLRA). Our rights under the contract are enforced through our grievance and arbitration process and our rights under the NLRA are enforced through the National Labor Relations Board (NLRB).

A. No. Stewards may insist that members obey union rules. Encouraging solidarity is protected by the NLRA even if a worker is upset or offended. The special protections afforded union representatives apply to a broad range of grievance-related activity, such as persuading witnesses to testify.
