An APV9T Transfer/Tax Form is an ICBC form used to transfer a motor vehicle from one person to another. It includes a description of the vehicle, minimum required declarations, the purchase price, the names and addresses of the buyer and seller, both signatures, the date of purchase and the odometer reading. By law this form must be completed within 10 days of a change in ownership.

I do know that when you transfer ownership of a motor vehicle ICBC requires that you complete form APV9T, the Transfer/Tax form. The purchaser is then required by the Motor Vehicle Act to present the form and register the vehicle within 10 days of the transfer.

ICBC will not accept any forms that have errors, crossing off, or are altered in any way; If the vehicle will be primarily used in a participating AirCare territory, a current passed AirCare certificate may be required; 12% tax on the purchase price is payable by the purchaser, unless an exemption applies
